Expulsion from a trip may, at the sole discretion of the Board of Directors of SJSC voting at a regular or emergency meeting, result in expulsion from any and all future SJSC events, pending a full hearing according to the club's Constitution.

I acknowledge that I have been informed that travel insurance is available and recommended should I desire to purchase it.
